Laboratory note: The estimated concentration of the unknown peak in the sample is 0.60% | Currently PharmLabs laboratory can not confirm an unidentified peak in your chromatogram due to interference (only with highly concentrated DB products) from which we believe to be either (+)-9S-THC or (-)-9R-THC. At this time there are no reference standards available for (+)-9S-THC, (-)-9R-THC is a different compound from the main (-)-9S-THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)-9S-THC and (-)-9R-THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)-9S-THC and (-)-9R-THC with the majority, if not all, of the concentration being (-)-9S-THC. Total (+/-) DB Concentration is estimated to be: 6.74%
